Small Business Trivia



KO Explanations

If the Offeror identifies a small business concern as a subcontractor in a bid, proposal, or subcontracting plan, the Offeror must provide the Contracting Officer with a written explanation if the Offeror fails to acquire articles, equipment, supplies, services, or materials as described in the bid, proposal, or subcontracting plan.



Mentor Protege

In an SBA MP agreement, a JV between a mentor and a protégé can be formed once throughout the lifetime of the 6 year MPA between the mentor and the protégé.

Untimely Payments

A small business subcontracting plan must include assurances that the Offeror will pay its small business subcontractors on time and in accordance with the terms and conditions of the underlying subcontract, and notify the contracting officer when the prime contractor makes either a reduced or an untimely payment to a small business subcontractor.



Lesgislative Updates

Fiscal Year 2023 National Defense Authorization Act

Tightened payments for subcontractors, Increased the SDVOSB goal from 3% to 5%, required SDVOSB's to be certified by the SBA by Dec 22, 2024 (or have an application pending on this data) & calls for DoD contracting officers to consider the past performance of small business affiliates.

Mentor Protégé Program Made Permanent

The Defense Acquisition Regulations System, Department of Defense proposes to modify DFARS subpart 219.71 and DFARS appendix I to implement section 856 of the NDAA for FY 2023, which authorizes on a permanent basis and modifies the DoD Mentor-Protégé Program (the Program).

Credit for Lower Tier Subcontracting

Effective November 13, 2023, the SBA issued a final rule that will permit a prime contractor with an individual subcontracting plan to apply credit for subcontracts to small businesses at lower tiers toward its subcontracting goals. To do so, the prime contractor would incorporate the lower-tier subcontracting performance into its subcontracting-plan goals.
